## I. Information We Collect

We collect information from You when You use the Website, contact or interact with us, sign up for Our newsletter or other mailing list, use Our services, such as the MyFS software and web applications ("MyFS Platform"), and voluntarily provide us with Your comments and other content in connection with using the Website.

The information we collect from You may include Personal Information and other information that is not Personal Information. For the purposes of this Privacy Policy, the term "Personal Information" means

any information that is defined to be personal information under applicable privacy laws. Usually, this refers to any information about an identifiable individual or any information that can be used to identify an individual. If We sell our organization or merge with another party, or engage in corporate restructuring or other corporate functions, Your consent is hereby provided, and will be otherwise implied, to transfer Your information to Our successor or such other parties with which we merge, restructure or engage in corporate functions, for the same purposes as set out in this Privacy Policy.

**Consent Exceptions:** There are legal exceptions where We will not need to obtain consent or explain the purposes for the collection, use or disclosure of Personal Information. Some examples of situations where consent is not required include an emergency that threatens the life, health or security of an

individual, or if We must comply with a court order or governmental order. We use may use Personal Information without Your knowledge or consent in limited circumstances whereby We are required to provide Personal Information to third parties for legal or regulatory purposes. For example, under certain exceptional circumstance We may have a legal duty or right to disclose Personal Information without Your knowledge or consent. This aggregated information does not contain Personal Information about any user. This anonymized information, which may also be aggregated in some instances, does not contain identifiable Personal Information and will be generated in accordance with applicable laws.
